JOURNAL

Volume IX, Nos. 1 and 2, of the Journal of the Society was published during the year. Judging from the requests received for exchange the Journal continues to draw great appreciation in India and abroad. Among the requests for exchange approved by the Council of the Society during the year under report are those from The Review of Economics and Statistics, Harvard University, U.S.A. and from The Statistical Review, Central Bureau of Statistics, Sweden.

The Hindi supplement continues to be a feature of the Journal. This represents an attempt on the part of the Society at precise expression of the scientific discussion of the subject in the national language.

It has now been decided to include a new section called "News and Notes" in the Society's Journal.

OTHER ACTIVITIES

- (a) The Society's publication, Sampling Theory of Surveys with Applications, by Dr. P. V. Sukhatme, continues to be well received. 400 copies of the new edition of the book printed at the Iowa State College Press, Ames, Iowa, U.S.A., have been received by the Society, and orders for supplying the book from the new stock are being received in the Society's Office. The Spanish edition of the book is also in great demand in Latin American countries.
- (b) In order to promote research in Statistics, it was decided at the last Annual General Meeting of the Society held at Bangalore, to institute prizes for articles of sufficiently high merit published in the Journal and to grant research assistance to promising workers lacking suitable facilities for research. Special announcements giving details of the two schemes have now been published in Volumes IX and X of

the Society's Journal. These have also been communicated for circulation (or printing) to important Research Institutions, Universities and research journals in the country and abroad.

The news of grant of the first two awards of Research Assistance made by the Society in this connection is being published in the Journal of the Society.

- (c) The Society was represented at the 18th Annual Conference of the Indian Society of Agricultural Economics held at Nagpur in December 1957, by Dr. S. R. Sen. The Society approached the Government of India for financial assistance to enable the Society to depute a delegate to the Special Session of the International Statistical Institute held at Brussels, Belgium, in September 1958, but the Government could not accede to the Society's request. However, Dr. P. V. Sukhatme and Dr. K. R. Nair attended the Session on behalf of the Society. Dr. K. R. Nair presented at this meeting on behalf of the Society a joint paper with Dr. K. Kishen on "Recent Developments in Experimental Designs with Special Reference to Work done in India".
- (d) The Society decided to organise a Seminar on the Techniques of Agricultural Costing jointly with the Indian Society of Agricultural Economics. A small Sub-Committee of both the Societies will frame the issues in detail and approach the F.A.O. through the Government of India for help.
- (e) The Eleventh Annual General Meeting of the Society was held at Vidhana Soudha, Bangalore, from 12th to 14th January 1958. The members showed keen enthusiasm in attending the meeting and participating in the discussions. A welcome address was given by Shri Ramakrishna Hegde, Deputy Minister for Planning and Development. Government of Mysore. The meeting was then inaugurated by Shri T. Mariappa, Minister for Finance, Government of Mysore, and was followed by a Technical Address on "The Role of Statistics in Experimental and Natural Sciences" by Bharata Ratna Dr. Sir C. V. Raman. Two sessions for reading of contributed papers were held under the Chairmanship of Dr. G. R. Seth and Dr. K. Kishen respec-A Symposium on "Role of Operational Research in Agriculture" was also held under the Chairmanship of Shri B. D. Panth and was well attended. The participants included Dr. P. V. Krishna Iyer, Dr. V. G. Panse, Shri V. R. Rao, Dr. G. R. Seth, Dr. B. H. Iyer, Shri Jacob, Dr. K. Krishen and Dr. V. N. Patankar. A lecture on

"A Practical Approach to our Food Problem" was given by Dr. V. Subrahmanyan, Director, Central Food Technological Research Institute, Mysore, and was presided over by Shri K. Ramiah, F.A.O. Consultant. A cultural programme and film show arranged by the Potascheme, Bangalore, were other features of the meeting. The Government of Mysore made a generous grant on the occasion to enable the Society to meet at Bangalore and the General Body of the Society has recorded a grateful vote of thanks to the Mysore Government.

The Symposium on "The Role of Operational Research in Agriculture" has been published in Volume X of the Society's Journal.
