INDIAN SOCIETY OF AGRICULTURAL STATISTICS

FIFTH ANNUAL REPORT, 1951-52

This Report gives a brief review of the Society's activities for one year from 1st July 1951 to 30th June 1952.

MEMBERSHIP

There were 233 members at the end of the year as against 222 last year. They were classified as follows:

ACCOUNTS

The opening balance at the beginning of the year was Rs. 13,608–15–1. The total receipts and expenditure during the year were Rs. 8,828–14–10 and Rs. 5,935–12–5 respectively. The main item of expenditure during the year was the cost of printing the Journal amounting to Rs. 3,621–2–0. The year closed with a balance of Rs. 16,502–1–6 of which a sum of Rs. 2,826 which was realised on account of fees for the two Summer Sessions of lectures arranged by the Society during 1950 and 1951, has been kept apart for publication of the book on Sample Surveys.

JOURNAL

Two issues of the Journal were brought out during the year. The Journal continued to be in demand from foreign countries. Some further requests were received for exchange of the Journal. The Council of the Society agreed to the request of the South Asia Science Co-operation Office of the UNESCO for the supply of the Journal free of cost.

OTHER ACTIVITIES

- (a) The Society has undertaken the publication of the book on Sample Surveys by Dr. P. V. Sukhatme, mainly arising out of the lectures delivered by him at the two Summer Sessions arranged by the Society during 1950 and 1951. This book under the title "Sampling Theory of Surveys with Applications" is already in press and is expected to be out in another 6 months. While the book is bound to make a wide appeal to statisticians both in India and abroad, the cost of the publication containing as it does extensive mathematics, is high and is estimated to be of the order of Rs. 15,000. This means a very considerable strain on the Society's financial resources. In this connection it is proposed to set up a separate publication fund for supporting the further programme of publications which the Society is planning to undertake.
- (b) The Society has interested itself indirectly in the reactivation of the Biometric Society in India. This Society is an international organization, consisting of biological workers interested in statistics and statisticians for the promotion of the use of quantitative mathematics in various biological fields, such as agriculture, genetics, medicine, etc. The Indian group has been reconstituted recently with Dr. V. G. Panse, the Secretary of the Society, as its Secretary and the Society and this group have jointly planned to hold a symposium on "New Problems in Experimentation" at the time of the next annual meeting of the Society.
- (c) The Fifth Annual Meeting of the Society was held at New Delhi on 11th, 12th, 13th and 14th December 1951. The meeting was attended by the members of the Society from all parts of the country and was inaugurated by Dr. Rajendra Prasad, President of India, who is also the President of the Society. Many foreign statisticians who had come to Delhi in connection with the International Statistical Conference, India, 1951, also participated in the proceedings of the Society. The delegates and visitors were welcomed by Shri K. M. Munshi, Minister for Food and Agriculture, Government of India. In addition to reading of technical papers, two symposia

were arranged during the meeting, one on "The Role of Complete Enumeration and Sampling in Agriculture" and the other on "A Statistical Appraisal of the Five-Year Plan for Agriculture". The first symposium was presided over by Shri R. A. Gopalaswami, I.C.S., Special Secretary (Ministry of Home Affairs) and Registrar-General of India, and the second by Shri K. M. Munshi. Both discussions were of considerable topical interest and a number of speakers participated. Another notable feature of the annual meeting was a popular lecture by Dr. L. H. C. Tippett of the Shirley Institute, Manchester, U.K., on "Why is Statistics so Useful?" which was presided over by Shri K. R. Damle, I.C.S., Joint Vice-President of the Indian Council of Agricultural Research.

Details of the programme arranged on the occasion of the meeting together with the proceedings of the business meeting are reproduced below. The inaugural address delivered by Dr. Rajendra Prasad has been published in Vol. V, No. 1 of this Journal.
